

Expanded the list of B3 Listed products that can be traded by U.S. Person.

Intended for segment participants: Listed

Summary: Ethereum Futures, Solana Futures and their rollovers enter the list of products that can be traded by U.S. Persons, as determined by the U.S. Commodity Futures Trading Commission.

Since 06/01/2016, B3 has been allowed to act as a Foreign Board of Trade (FBOT), allowing investors from the United States (U.S. Person) to access, directly from their country, products from our Listed segment authorized by the U.S. Commodity Futures Trading Commission (CFTC).

As of 06/16/2025, the list of authorized products will be expanded to include four new products: Ethereum Futures Contract, Structured Ethereum Futures Contract Rollover Operations, Solana Futures Contract and Solana Futures Contract Structured Rollover Operations. The complete list can be found in the Annex to this External Notice and also on <u>B3's website</u>.

Access to the products is via a sponsored direct connection, where the execution solution administrator is the authorized principal. We offer multiple modalities of sponsored direct connection, as provided in our Trading Operating Procedures Manual, whose infrastructure characteristics can be accessed <u>here</u>.

Compliance with specific authorizations is the responsibility of the intermediaries, who must ensure that the investor adheres to the rules for access to the markets managed by B3. As a market infrastructure, we periodically monitor the fulfillment by intermediaries of the obligations mentioned herein.
