Re.: **Treatment of B3 Indices' Portfolios and of Assets Deposited as Collateral to Account for the Incorporation of Grupo de Moda Soma S.A. by Arezzo Indústria e Comércio S.A. (new corporate name Azzas 2154 S.A)**

Procedures for the indices' portfolios

We will adopt the adjustment procedures described below for the **August 1, 2024** trading session opening, in accordance with the Material Event Notice published by the companies Arezzo Indústria e Comércio S.A. and Grupo de Moda Soma S.A. on June 18, 2024.

Furthermore, due to the change of the corporate name of Arezzo Indústria e Comércio S.A. (ticker ARZZ3) to AZZAS 2154 S.A., as of **August 1, 2024**, AZZAS 2154 S.A. equities will be traded under the new "AZZA3" ticker.

In the Bovespa Index (Ibovespa) (IBOV), Brazil Broad-Based Index (IBrA), Brazil 50 Index (IBXL), Brazil 100 Index (IBXX), Carbon Efficient Index (ICO2), Consumer Stock Index (ICON), Corporate Governance Trade Index (IGCT), Special Corporate Governance Stock Index (IGCX), Novo Mercado Corporate Governance Equity Index (IGNM), Corporate Sustainability Index (ISE), Special Tag-Along Stock Index (ITAG), Valor BM&FBOVESPA Index (IVBX) and SmallCap Index (SMLL), SOMA3

equities will be excluded after the close of trading on July 31, 2024, at the price of the last transaction executed at B3. The respective theoretical quantity, divided by the exchange factor (0.121695988348), will be incremented to the theoretical quantity of AZZA3.

In this way, for the IBOV, IBRA, IBXL, IBXX, ICON, IGCT, IGM, ITAG, IVBX and SMLL indices, the final quantity of AZZA3 will be 122,670,748 shares; for the ICO2 index it will be 89,585,729 shares; for the IGEX index it will be 245,341,496 shares; and for the ISE index it will be 242,441,104 shares, respecting the methodology.

There will be no adjustment to the reduction factors as a result of the conversion. In this way there may be a difference between the closing values of these indices on July 31, 2024 and their pre-opening values for August 1, 2024.

For the B3 Smart High Beta Bovespa Index (IBHB), the theoretical quantity of ARZZ3 will not change, as described in item 3.5, subparagraph IV of the Concepts and Practices Manual for B3 Indices available at www.b3.com.br/en_us, Market data and Indices, Indices, Broad Indices, Bovespa Index (Ibovespa), being adjusted only in the next periodical rebalancing.

For periodical rebalancing purposes, the processing of historical data will be executed with the migration of 100% of the trading history of SOMA3 to AZZA3.

The reduction factors of all the above indices may be adjusted in the case of corporate actions that occur with the other assets that comprise the portfolio.

Assets deposited as collateral

On the action's execution date at the B3 Central Depository, the SOMA3 and ARZZ3 shares deposited as collateral will be converted into AZZA3. The AZZA3 shares will be eligible for deposit as collateral, in accordance with the collateral eligibility criteria described in item 6.3 (Limits for accepting assets as collateral) of the B3 Clearinghouse Risk Management Manual, available at www.b3.com.br/en_us, Regulation, Regulatory Framework, Regulations and manuals, Clearing, settlement and risk management, Access the documents.
